

SUMMARY OF JOB DESCRIPTION

Under the general supervision of the Chief Executive Officer (CEO), the Chief Financial Officer (CFO) is responsible for all fiscal matters including the design, operation and control of effective administrative procedures related to accounting, payroll, property control and procurement. This position is responsible for determining the adequacy and completeness and providing guidance and consultation, achieving maximum competency in application of program regulations. The Chief Financial Officer acts as the financial adviser to the CEO. This person is responsible for and supervises all personnel assigned to him/her. Duties include, but are not limited to: informing Chief Executive Officer of program activities through weekly, monthly, and/or quarterly scheduled reports; designing, operating, and directing an effective accounting system, budgetary control system, including budget preparation and budget status reporting. This person must possess effective financial reporting skills in systems which provides the basis for issuance of timely and accurate financial statements; Advises component directors concerning fiscal and budget matters; Assists in developing and/or updating manuals, procedures, specifications, etc., relative to organizational requirements; Works closely with other directors, coordinators, specialist in other departments with accounting or data needs and with vendors.

EMPLOYMENT QUALIFICATIONS

Graduation from an accredited four year college or university with a minimum of twelve (12) semester hours in Accounting, plus two (2) years of professional experience in accounting or auditing work.

Experience in which accounting or bookkeeping was the primary duty may be substituted for the required college training on a year for year basis. The completion of a nine (9) or twelve (12) month business course which included accounting subjects may be substituted for on (1) year of college training.

Graduation from an accredited four year college with a major in Accounting plus one (1) year experience in accounting or auditing work.

Resume's will not be accepted in lieu of a completed application, but may be attached. Completed applications are due in the Department of Human Resources at 501 St. John Street, in Lafayette by 12 noon on Friday, September 29, 2017.
